



The 2010 KZYX&Z Raffle in Partnership with Ukiah Natural Foods Official Rules



- The "KZYX&Z 2010 Raffle" ("Raffle") is sponsored by KZYX&Z ("KZYX&Z" or "Sponsor"), a listener and member supported public and community radio station, licensed to broadcast from Philo, Willits, and Fort Bragg, Mendocino County, California. KZYX&Z is on the web at www.kzyx.org. KZYX&Z is owned and operated by Mendocino County Public Broadcasting, a 501(c)(3) tax-exempt non-profit, non-partisan, California Corporation, recognized by the IRS: FID#68-0050440. - Raffle is open to citizens and residents of the State of California only, age 18 years old or older. Void where prohibited. All federal, state, and local laws and regulations apply. Employees of KZYX&Z and Ukiah Natural Foods and their immediate family members are NOT eligible to participate.
- All net Raffle proceeds will benefit KZYX.
- The drawing will award one prize, valued at \$5000. The winner will have a two-year charge account at the Co-Op. The winner can stipulate who may charge goods using this account. All persons using the charge account must show proper ID at the register. No cash will be given out for any return of merchandise purchased using this account. Returns will be credited to the account. Charges can be made for goods only. No tickets or ticketed events, and no member shares can be purchased with this account. Account is valid only at Ukiah Natural Foods, 721 South State Street, Ukiah, California. All other federal, state, and or local taxes are the sole responsibility of the winner. There is no cash option for winner. Prize must be used within 24 months of drawing. Any unused balance in the account will be forfeited after two years.
- Winner will be determined by a random drawing from all eligible entries. All decisions are final and binding. Odds of winning are based on the number of tickets sold. The winner will be notified by fax, e-mail, telephone, or regular mail, depending on information provided by/on winning ticket. Sponsor is not responsible for and shall not be liable for late, lost, misdirected, or unsuccessful efforts to notify winner.
- Winner may be required to sign and return a release of liability, declaration of eligibility, and, where lawful, a publicity agreement, in connection with accepting prize, all within 14 days of notification. By accepting and/or using prize, winner agrees to the use of his or her name, voice, or likeness for the purpose of advertising, trade, or promotion without further compensation, unless prohibited by law. If a selected winner cannot be contacted, is ineligible, fails to claim a prize, obtains the winning ticket through fraud of any kind, or fails to timely return the completed and executed affidavit and releases as required, prize is forfeited and an alternate winner will be selected.
- By entering, participants agree to be bound by these Rules & Regulations and the decisions of Sponsor, which shall be final. Sponsor, agents, and representatives of Sponsor; affiliates; advertising, promotion, and ticket or fulfillment agencies, and legal advisors, are not responsible for and shall not be liable for (i) late, lost, delayed, damaged, misdirected, incomplete, illegible, unintelligible, or postage-due entries; (ii) telephone, electronic, hardware or software program, network, Internet, or computer malfunctions, failures, or difficulties of any kind; (iii) failed, incomplete, garbled, or delayed computer transmissions, (iv) any condition caused by events beyond the control of the Sponsor that may cause the Raffle to be disrupted or corrupted; (v) any injuries, losses, or damages of any kind arising in connection with or as a result of the prize, or acceptance or possession, or use of the prize, or from participation in the Raffle, or (vi) any printing or typographical errors in any materials associated with the Raffle. Sponsor reserves the right, in its sole discretion, to suspend or cancel this Raffle at any time if a computer virus, bug, cyber-vandal, or other technical problem corrupts the administration, security, or proper play of the Raffle.
- Participants agree to release and hold Sponsor and the employees, officers, directors, agents, and representatives of Sponsor; affiliates; advertising, promotion, cagers, and fulfillment agencies; and legal advisors, harmless from any kind of losses, damages, rights, claims, and actions of any kind in connection with the Raffle or resulting from acceptance, possession, or use of any prize, including without limitation, personal injury, death, and property damage, and claims based on publicity rights, defamation, or invasion of privacy.

- Each ticket constitutes one entry. There is no limit to the number of tickets that may be purchased by any individual provided they are qualified to participate as described above.
- Ticket holders need not be present to win. However, KZYX must [a] have clear information on how to reach winner, such information to be included on ticket entry, and [b] winner must respond to notification as described above. As of January 4, 2010, the raffle and drawing are expected to take place at Ukiah Natural Foods, 721 South State Street, Ukiah, CA, 95482, on May 31, 2010. Location, date, and time of drawing may be changed as determined by KZYX&Z and by Ukiah Natural Foods. Changes will be announced on KZYX&Z.
